

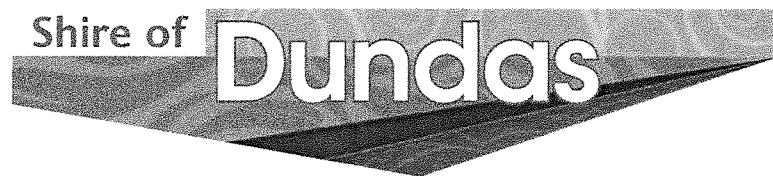

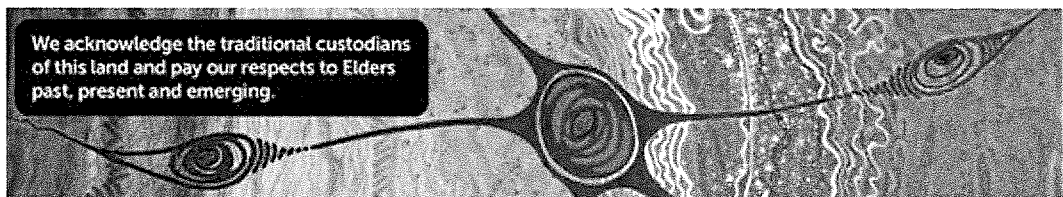
Our dogs are not animals to us, they are family members.

All dogs will be registered with the Shire of Dundas.

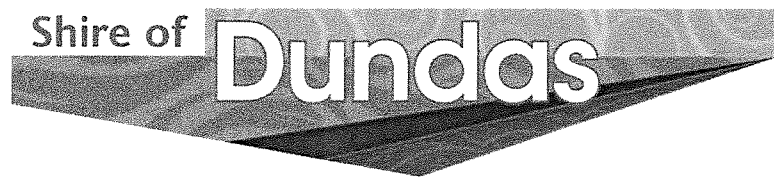

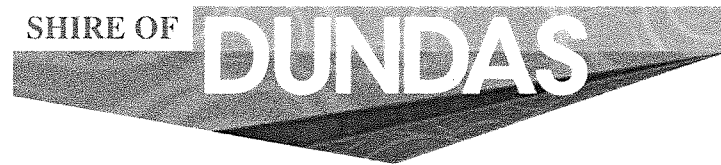

Visitor Traffic

Visitor traffic has increased over the month with majority of tourists heading over east. This is suspected to be due to some of the eastern states coming out of their lockdowns. Visitor requests are for the most part regarding the Eyre Highway and staff have been assisting with South Australian travel declarations. Spending in town, as recorded by the RV Park, has increased demonstrating a higher volume of visitor traffic.
