Dear Community Member / Organisation,

Memorials of Community Significance

The Shire of Dundas Council understands there are times when it is appropriate to recognise by way of a commemorative plaque or memorial a person, persons or event that has made significant contribution or had significant impact in the community.

Places of remembrance offer community a place of recognition and reflection and as such must be appropriate in their location, size and content.

It is important when making the application that you understand the requirements of Council to consider all factors when approving the installation of memorials. Council must look beyond the memorial itself, considering the environmental, safety, financial and community aspects of the installation.

Memorials of Personal Significance

The Shire of Dundas also recognises that with the loss of a loved one some families may wish to erect a cross or similar memorial. The Shire desires to deal with requests in a sensitive manner understanding that this is a sad and often distressing time for families.

Permanent personal memorials in public places must be considered carefully by Council as to the appropriateness and practical implications of the installation. Please meet with the CEO before applying.

White Crosses and Roadside Memorials

Main Roads WA is responsible for assisting families with roadside memorials on the Eyre and Coolgardie-Esperance Highways. Main Roads WA can be contacted via email enquiries@mainroads.wa.gov.au

Process:

- Applicant to complete and submit APPLICATION TO ERECT PLAQUES, CROSSES OR MEMORIAL IN PUBLIC PLACES form to the Shire.
- 2. A Shire Officer will prepare a report for Council regarding the application and may be in contact with you if more information is required.
- 3. Applications are approved or not by way of Council Recommendation at an Ordinary Meeting of Council.
- 4. Applicants informed of Council's decision.
- 5. If approved a Shire Officer will be assigned to assist you with the process of installation of the commemorative item.

Woodlands Centre Update

Construction Report

Interior Works:

- Preparation of Internal walls for gyprock.
- IT Solutions paid a site visit to advise on communications and IT requirements.
- Installation of electrical cabling and placement.
- By the time of Council meeting the framing of internal walls will be almost complete.
- Storage solutions and ease of accessibility for staff in the allocated Visitor Centre area was reworked.

- NBN application submitted
- Interior Style Guide Report completed

External Works

- The large support wooden beams for the entry walkway are now being installed.
- Concrete pad for external utility area complete, screening of utility areas and required enclosed areas being discussed to ensure woodlands theme and flow between Dodd House, Gallery and Centre.
- Panelling on Prinsep Street facing roof faced underway
- Upgrade of Dodd House electrics is being planned for to meet the higher requirements for outdoor lighting as part of the entry works.

Interior Style Guide

Kulbardi Hill Consulting have now completed the Style Guide which will be used by builders to assist in colour choices for interior and fixed fittings. The guide is focused on the interior of the Centre, builders have been mindful to see the interior colour palette considered when choosing colours for the exterior.

In development of the guide the diversity of the Great Western Woodlands has been considered. Anyone who have spent time in our Woodlands will recognise the vibrancy and diversity of colours and themes. This of course does not exclude the tones and hues of the Shire's extensive coastline being featured in the Centre through artwork, photography and featured displays.

Eucla LEMC Meeting

The Shire of Dundas Local Emergency Management Committee conducted their August meeting in Eucla, which saw an attendance of over 30 people and services responsible for emergency response along the Eyre Highway.

Key discussion points during the meeting were;

- Remote Patient Retrieval
- Communications between responding organisations
- Decision making process and timeframes around patient retrieval
- Emergency Services Volunteers workload and expectations.
- Airstrips along the Eyre Highway

Youth

The youth centre is averaging about 25 kids per day aging from 7 - 16yrs. Tuesday, Thursdays and Saturday mornings are still open for ages 7-11yrs. Now that the days are getting longer kids aged 5-8 yrs are staying down town later and getting a lift home on the youth bus although the Shire of Dundas are all about youth safety and wellbeing it is important to remember that the Youth Centre is for youth kids aged 12-18yrs and kids aged 5-10yrs should be off the streets by 5pm and parents to know where their kids are always.

Arising issues with relationships and home life that are influencing the behaviour of youth that are coming into the youth centre and how they interreact with each other, small concerns for some youth as they are becoming more with drawn from peers and activities. Have made contact and currently keeping an eye out for them.

The youth Centre has been loud and busy since returning from the July school holidays, now that the weather is getting warmer the youth are getting out and about playing 4 square, basketball and even had a game of chasey on the weekend. October school holidays are coming up fast currently planning some fun activities and getting the kids involved to help plan the holidays looking at having Joel and Imanee from Dept of Health come down to do sex education with the youth having a girls day and boys day inn at the youth centre.

Playgroup

Playgroup is open on Tuesday from 10am – 12pm and currently looking at doing playgroup on Friday as well. There is a \$2.00 fee and we ask for the parents to bring a piece of fruit to share for morning tea. Currently there are 5 kids that attend aging from 12months – 3yrs. Early learning and play is important as it helps young kids develop social skills, communication, hand eye coordination and helps the brain grow. At Playgroup the kids have access to loads of different toys, books and craft activities also running the better beginnings program to encourage families to read more to there kids, this is also a good way for mums and dads to mingle with each other as some mums that attend playgroup are new to Norseman and from different backgrounds it has created a barrier for communicating and mingling, but over the last 4 weeks of running playgroup not only have the kids come out of their shells but some of the mums have too. Looking at 4th October to start doing playgroup on Friday.
