<u>Summary</u>

For Council to note the recent concerns expressed by Water Corporation and the actions taken by shire administration in limiting the availability of water from the Shire's standpipe.

Background

Earlier in the month the Shire had a visit from John D'Arcy, Regional Manager from Water Corporation. John advised that as a result of excessive use by third parties, the Shire's standpipe had reserves for a further 3 days only and that the standpipe should be shut down for a two day period and thereafter have a limited off take of 50,000 kl per day.

Having identified the main users of the facility, Water Corp advised the Shire that the standpipe was never meant to operate as a commercial entity and was for the Shire's own use and for fighting fires and other emergencies. If the shire intended operating the standpipe as a commercial entity then the cost of the water would increase by approximately \$10 per kl.

The shire has received several letters and visits from Norseman Concrete on the matter including concerned calls from local politicians.

Based on the current correspondence (17th November) shire management contacted Water Corp requesting an update on the situation and confirming again that the Shire had no interest in operating a commercial operation.

The response from Water Corp was that Norseman Concrete would be advised of the Shire's view. Water Corp would recommend to Norseman Concrete that if they intended to transact in water then the only viable option was for Norseman Concrete to apply for their own standpipe.

The off-take by Norseman Concrete although not necessarily on a daily basis, could fluctuate around 40,000 to 60,000kl per off-take.
