Founded by three animal-lovers in 2005, SAFE Perth - Saving Perth Animals from Euthanasia has now grown to a dynamic organisation of over 300 dedicated, compassionate Volunteers and Foster Carers. From day one, we made a commitment to be a no-kill rescue. The dedication and hard work of our team ensures that cats, dogs, and other animals are saved from euthanasia every week, across WA.

Due to our success in helping the neediest animals in a range of circumstances, we're often called on to assist local rangers, vets, and police.

Our rescued animals come from all parts of the state, ranging from Broome and Halls Creek in the north to Collie in the south and Norseman in the east, some from the most horrendous circumstances. These animals sometimes need to be flown to Perth because of the lack of transport and sometimes require intensive vet care to get them to the adoption stage. During this time, they usually spend time with our volunteer foster families. This can turn out to be very expensive and, as we have no financial subsidies from governments, we totally rely on volunteers and donations. No matter the cost to the organisation to get them to the adoption stage, the adoption fee is the same across the board.

We at SAFE Perth - Saving Perth Animals from Euthanasia rely on the generosity of the public to continue saving animals from early and unnecessary death. Your dollar makes an enormous difference.

## **Saving Perth Animals From Euthanasia Inc. ('SAFE Perth')**

### **Volunteer Code of Conduct**

This document outlines the minimum standards of behaviour required of ALL persons volunteering their service to SAFE Perth.

The code is designed to ensure that all Volunteers are aware of their obligations and responsibilities, and covers the behaviour expected of all Volunteers at any SAFE Perth event or on any mailing list, forum, website, in private correspondence, telephone conversations, adoption viewings or at any public meetings.

#### **Responsibilities**

As a Volunteer of SAFE Perth, you are required to act responsibly, professionally, ethically and display a high regard to customer service standards as a representative of our organisation.

At a minimum, all volunteers are expected to:

- At all times, act in a manner that promotes and enhances the good reputation of SAFE Perth.
- Be considerate. You are working with others as a team, so be considerate of how your actions or contribution may affect others.
- Be respectful. Treat other Volunteers, and members of the public, with respect.
- Be courteous, friendly and cooperative with other Volunteers and members of the public.
- Offer constructive feedback about our organisation, in an appropriate manner.
- Direct any concerns regarding our organisation to the appropriate Committee Member.
- Follow through on your commitments, and advise your Committee Member as soon as possible if you are unable to do so.
- Demonstrate respect for the direction and decisions of the SAFE Perth Management Committee.
- Take reasonable care for your own health and safety, and ensure your conduct does not adversely affect the health and safety of others.
- Ensure that you are not under the influence of alcohol or drugs whilst representing SAFE Perth.
- Respect the confidentiality of information you may receive whilst volunteering with SAFE Perth and do not pass information along to third parties without express permission from your Coordinator/Committee Member. This includes information you may receive via social media or in private correspondence such as email.

- Make appropriate use of the donated resources available to foster carers of SAFE Perth and do not pass goods onto third parties without permission from the SAFE Perth Management Committee.
- Refrain from engaging with pounds, veterinary surgeries or animal care authorities on behalf of SAFE Perth without first obtaining permission to do so from the relevant Coordinator/Committee Member.
- If you are volunteering for SAFE Perth as a foster carer, ensure that you observe and follow the procedures outlined in the SAFE Perth Foster Carer Manual at all times. Foster carers with SAFE Perth must not foster with any other group or organisation without written permission from the relevant Coordinator/Committee Member.

Failure to adhere to any or all parts of this Code of Conduct may adversely affect the reputation of SAFE Perth and result in suspension from your volunteer duties, and/or termination of your volunteer relationship with SAFE Perth.

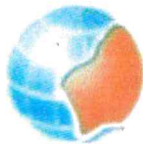
