Summary

That Councillors of the Shire of Dundas in consultation through GVROC and recently Shire of Esperance has indicted a strong interest in joining the DAMA and that Council note the report on the Designated Area Migration Agreement (DAMA), as the Shires that has an interest in the DAMA Program has to share a boundary with each other it is in our interest to assist the Shire of Esperance that also battles the same issues as we do by joining the DAMA Program.

Background

The Shire President and Chief Executive Officer have through the GVROC identified that there is a potential of bringing additional workers to our remote resource communities through the DAMA arrangement. In our last workshop we had DAMA as an item and issues discussed was facilitating the immigration of skilled workers to the region by negotiating Designated Area Migration Agreement (DAMA). For the Shire of Dundas to join the DAMA the President has written to Hon. Alan Tudge MP the A/Minister of Immigration, Citizenship and Multi-Cultural Affairs to consider our application to join the

DAMA Program currently being administered through the City of Kalgoorlie Boulder. The DAMA is supported by the GVROC as a concept for attracting people back to the Goldfields Esperance Region.

At this there is no immediate of cost other than staff and Elected Members time attending to this matter, and the cost is covered under our current operational budget, but we will attempt to allocate \$10,000 in the 2020/21 Financial Year Budget to assist with the promotion of this program.

Comment

The DAMA program is a two-tiered agreement between the Commonwealth and a state/territory or regional body that provides:

- flexibility for a Designated Area Representative (DAR) to respond to their local economic and labour market needs and conditions
- solutions to Australian business where there are skills gaps and shortages that can't be met by the Australian market
- streamlined access to a broader range of overseas workers than available through the standard skilled visa programs
- various negotiable concessions to the standard skilled visa requirements; and
- pathways to permanent residence as major incentives to attract and retain overseas workers

Tier 1: Designated Area Migration Agreement with state/territory government or regional representatives – outlines responsibilities, governance and overarching policy settings for a region

Tier 2: Individual labour agreements under the DAMA

 one for each employer sponsoring workers in the DAMA region, accords with policy settings agreed in the DAMA.

There is one DAMA in place with the Northern Territory Government, and the GVROC Shires including the Shire of Coolgardie and the City of Kalgoorlie Boulder, Shire of Leonora, Shire of Menzies.

Roles and Responsibilities regarding the DAMA.

Minister for Immigration, Citizenship and Multicultural Affairs

- Power to enter into a DAMA with a state or territory Government and regional authorities for a defined geographic region in Australia
- · Authorises the conditions and parameters under a DAMA

- Co-signs the DAMA
- · Assessing and endorsing employers who want to sponsor migrant workers under the DAMA
- Monitor activity, report on issues
- Engagement and consultation with the Department of Home Affairs, employers and stakeholders as required
- Annual review of DAMA terms/operations

Department of Home Affairs

- Submits the DAMA request to the Minister for review and decision
- Works with the DAR to establish and negotiate terms of the agreement and monitor progress, issues and effectiveness of DAMA
- Works with endorsed employers to establish labour agreements and process nomination and visa applications made under the agreements
- Reports to Minister on DAMA outcomes

Employers

- Seek endorsement from the DAR to sponsor migrant workers under the DAMA
- Enter into individual labour agreements (under the umbrella of the DAMA) with the Department of Home Affairs
- Lodge nominations to fill vacancies under the Temporary Skill Shortage visa for a 4-year period (unless otherwise specified) or permanently under the Employer Nomination Scheme visa
- Are subject to temporary residence sponsorship obligations and a sanctions framework under existing Migration law.

The outcome with the DAMA Program is to find Skilled Workers willing to establish themselves in the remote resource communities to assist in ensuring these communities sustainability.

The DAMA will come into play after efforts on local employment is exhausted and there is no other option to attract candidates to our region.

Summary

Shire of Dundas is a unit holder and beneficiary to the Local Government House Trust, holding 3 unit/s as advised in WALGA's recent Quarterly Report Q4 2019.

The Trust's Board of Management is seeking to vary the Trust Deed in order to assist the Trust's income tax exempt status. As stipulated by the Deed, the Trust requires consent of at least 75 per cent of all beneficiaries in order to execute this variation.

As a beneficiary, the Shire of Dundas is requested to consent to the enclosed Deed of Variation supported by a resolution of Council; and to communicate this consent to us in writing. Please note, we are requesting consent for the Trustee to formally execute the attached Deed of Variation – your Local Government is not required to sign the enclosed document.

Further details on the particular Deed Variations and objectives to be achieved by this variation are outlined below.

Background

The Local Government House Trust ("The Trust") exists primarily to provide building accommodation for the Western Australian Local Government Association. Since January 2014, the Trust has provided WALGA with accommodation at 170 Railway Parade West Leederville.

The current trust deed commenced in 1993 and was amended in 2002 to reflect the merger of the metropolitan and country associations into WALGA. The current Trust Deed pronounces WALGA as Trustee and unit holders as Beneficiaries, with the Trustee holding property and associated monies "upon Trust" and in proportion to the units provided.

Commencement date of the current deed is 17 February 1993, with a vesting date 79 years from commencement - which means that the Trust ends in 2072.

The Trust is exempt from income tax on the basis of being a State / Territory Body (STB) pursuant to Division 1AB of the Income Tax Assessment Act 1936.

Trust Deed Variation

Trust Deed amendments set out in the Deed of Variation are based on legal advice and are intended to assist the Trust's income tax exempt status by strengthening the position that the Trust is a State / Territory Body (STB).

Legal advice identified that the Trustee's ability to retire and appoint a new Trustee might affect the Trust's classification as a State or Territory Body (STB). This view, while based upon highly technical grounds, is a risk nonetheless.

Subsequently the Deed of Variation aims to strengthen the position that the Trust is a STB through the following amendments:

- removing the existing Trustee's power to retire and appoint a new Trustee (Clause 2.1 and 2.2 (22.3) of the Deed of Variation)
- 2. enabling the beneficiaries to appoint and remove a Trustee (Clause 2.2 (22.4) of the Deed of Variation), and
- 3. ensuring that the Board of Management is the 'governing body' of the Trust (Clause 2.3 of the Deed of Variation)

The three proposed amendments when applied to the relevant clauses inserted by the Deed of Variation dated 5 June 2002 will subsequently read as follows (proposed amendments shown in red text):

1. Variation 2.1 amends clause 22.1 to point to additional clause:

22.1 Any Trustee of the Trust may retire as Trustee of the Trust. The Subject to clause 22.3, the right to appoint any new or additional trustee or trustees of the Trust is hereby vested in the retiring or continuing trustee. A corporation or incorporated association may be appointed as Trustee of the Trust.

2. Variation 2.2 inserts two new clauses:

- 22.3 The retiring or continuing trustee shall only be entitled to appoint any new or additional trustee of the Trust with the consent of not less than 75% of the Beneficiaries.
- 22.4 The Beneficiaries may at any time by Special Resolution:
- (a) remove a Trustee from the office as Trustee of the Trust; and
 - (b) appoint such new or additional Trustee.

Variation 2.3 insert a new clause 13A

13A Delegation to the Board of Management

Unless the Beneficiaries otherwise direct (such direction to be given by not less than 75% of the Beneficiaries), the Trustees shall delegate all of the powers authorities and discretions contained in subclauses (a) to (x) of clause 12 to the Board of Management. The Trustees shall, at the direction of the Board of Management, do such things as may be necessary to give effect to the exercise of a power, authority or discretion by the Board of Management.

Comment

The first two amendments outlined above remove powers granted to the Trustee in the 2002 Deed Variation resulting from the merger to a single Association representing WA Local Governments. These amendments which previously facilitated the transfer of trusteeship to the then new Western Australian Local Government Association are removed, but with the clarification that any appointment must be with the consent of the beneficiaries.

The final amendment intends to confirm that power rests with the Board of Management. As the Board of Management comprises Local Governments, this satisfies the requirements of a STB for tax purposes. This amendment reflects the actual operation of the Trustee in implementing the decisions of the Board of Management whilst retaining sufficient operational discretion to place and renew investments and pay suppliers.

These amendments provide greater power to beneficiaries through the Board of Management, and as such it is anticipated they will be considered acceptable.

WALGA is requesting Shire of Dundas to consider the above amendments and receiving formal consent to execute these changes via resolution of Council.

Summary

To report to Council that there is public petitions and Shires in South Australia in opposition to exploratory drilling/mining for fossil fuels in the Great Australian Bight.

Background

The following supporting information, including a copy of the Wilderness Society Campaign Brief (attachment 1) and the Equinor Environmental Plan in brief (https://www.equinor.com/en/where-we-are/gabproject.html), was provided by Monica Mudge, Take 2 SLSC project Manager, with the petition:

"Norwegian oil company, Equinor, plan to carry out exploratory oil drilling in the Great Australian Bight. The deepest drill proposed in the bight to date, in one of the wildest part of our oceans. It may be far away from us, but an accidental oil spill in this part of our oceans may have grave effects on our local beaches and waterways, and I believe it is important for this matter to be raised in council.

Here in the Shoalhaven, many local residents oppose this proposed drilling for many reasons and we are seeking the opportunity to raise our concerns with Shoalhaven City Council at your next special meeting. As a representative of ocean conservation in our area, I, along with so many of our rate payers and visitors alike, have grave concerns for what this drill could potentially mean for our beaches, our industries, our tourism and our wildlife. So much so that a petition proposing the Shoalhaven City Council consider opposing the drill, has now attracted over 1,000 signatures in writing and 873 online signatures to date, with those numbers rising every day.

As you may know, we are not the only community to be concerned, Peaceful protests and communities have been coming together across the country, some led by nationally acclaimed surfers and celebrities.

At this stage the final call needs to be made by NOPSEMA (National Offshore Petroleum Safety and Environmental Management Authority), and that is expected to happen sometime soon. We would like Shoalhaven City Council to formally support the banning of exploratory drilling in the Great Australian Bight before they make their decision.

There is substantial evidence to support our concerns and I have attached a brief outline for you. I have also read from cover to cover the draft Environmental Plan and final Environmental Plan provided by Equinor (also attached). As you will see, by their own admission, this drill is not 100% safe and should there be a spill, the catastrophic effects may see oil ending up here on our local beaches, not to mention what it will do in The Great Australian Bight, the main highway for wildlife (whales, sharks, dolphins, plus many more) found nowhere else in the world, some already endangered. <u>Summary</u>

For the Council to note the proposed amendments to the 2019/20 Budget.

Background

The Council is required (by regulation 33A of the Local Government (Financial Management) Regulations 1996) to conduct at least one budget review during the period from 1 January to 31 March of each financial year. The review must consider financial performance up to a period ending no earlier than 31 December. The adoption requires an absolute majority decision of Council and a copy of this review is to be forwarded to the Department of Local Government and Communities within 30 days.

The Department of Local Government and Communities has revised, issued Circular No. 06/2006 to provide local governments with information about the budget review process. The following paragraphs are key points from the circular:

A budget review is a detailed comparison of the year to date actual results with the adopted budget. It establishes whether a local government continues meeting its budget commitments; is in receipt of income and incurs expenditure in accordance with the adopted budget.

It is preferable for budget reviews to be conducted by senior staff. They understand the operations of a local government, the reasons for significant variances and the action required to address the problem. The results of the review and accompanying report from senior staff could be presented to the Audit Committee for consideration and advice to Council.

Regulation 33A (2) and (3) of the FM Regulations requires the results of the budget review to be submitted to Council within 30 days of the review. Council is then to consider a review submitted to it and determine whether or not to adopt the review, any part of the review or any recommendations made in the review.

Shire officers have reviewed the 2019/2020 budget in accordance with the provisions of the Local Government Act 1995 and have made some recommendations to ensure that a sustainable financial position is maintained. Details of the revised budget, in management format was presented at the budget review workshop for Councillors' review.

This review is based on performance to 31 December 2019.

Statutory Environment

The Local Government Act 1995 S6.2 states that local governments are required to prepare an annual budget. The Financial Regulations (r.33A) requires that between 1 January and 31 March of each financial year a local government is to carry out a review of its annual budget.

Policy Implications

Budget commitments need to be managed in line with applicable policies and procedures.

Financial Implications

The proposed amendments will deliver a surplus of \$ 238,728 the break-up of which is shown below.

Comments on those items which have a projected variance of over 10% and greater than \$5,000 have been provided under variance analysis section of the budget review report included in papers relating. In some instances, although the variance is outside of these parameters, due to their significance, comments have been provided.

In Summary,

Overall, the revised budget has delivered a net surplus of \$ 238,728. This surplus has been achieved for multiple reasons such as apparent cost savings, employee resignations, boost in income and deferment of projects to the next financial year.

Operating Expenditure

Total operating expenditure has increased by \$99,548. Despite many cost savings achieved, the net increase in operating expenditure has resulted from

(1) Bush firefighting expenditure on December 2019 event. The additional expenditure incurred on Dec 2019 bushfire amounts to nearly \$ 40k. However, the actual re-imbursement expected from DFES amounts to \$134k.

(2) Woodland Centre/Visiting Centre operations: As these functions have emerged during 2019/20, no allocations existed in the original budget for both operating expenditure and income. In the review, an allocation has been provided to cover operating expenditure for the Woodlands Centre of \$41k and the Visiting Centre of \$\$101k.

The additional operating revenue expected from these two functions included in the review amount to \$106k.

More realistic budgets for these two functions will be prepared for 2020/21 financial year after a trial period with formulation of a sustainable business model.

Cost savings in operating expenditure have mainly resulted from

- (1) General Administration across many functional units partly owing to vacant positions,
- (2) Some programs having not yet commenced.

Operating Income

An increase of \$221,036 is estimated in the operating income mainly due to

- (1) Interim rates being issued during the financial year,
- (2) Increase in grants and other contributions,
- (3) The anticipated income from reimbursement of Dec. 2019 bushfire fighting expenditure.

Capital Expenditure

Following the budget review, the capital expenditure is expected to decrease by \$33,959, which is a combination of

- (1) Decrease in transfers to cash-backed reserves of earnings on investments due to low interest rates,
- (2) Increase in expenditure on road-funded projects as approved by funding agencies,

Capital Income

The Budget review has increased the Capital income by \$83,281, owing to the Increase in R2R road funding as approved by the Funding Agency.
