Comment

Discussions have taken place between the Manager of Works and Services (MWS) and Aerodrome Management Services (AMS) regarding their design report for the upgrade of the Eucla airstrip. They have indicated that the design drawings (profile of the airstrip) should be available to the Shire by Monday, 26 March. As far as the actual cost was concerned, they are confident that there will be no increase in the \$2,651,690 estimate that they have prepared. However, that is also dependent on when the upgrade actually commences.

In comparing the previous Eucla airstrip upgrade report that AMS prepared in 2012 to the current design report, construction methods are reasonably similar. However, cost estimates have more than doubled since then, a period of a little over five and a half years. As such, any further delays in the upgrade will only increase the costs.

The MWS has been in discussions with Kate Mills from Puzzle Consulting with regards funding opportunities, timing and conditions relating to possible grants.

Both the State and Federal Department of Transport sections fund this type of upgrade, however, both Departments are quite explicit in their guidelines that all existing grants must be acquitted before any submission will even be considered. This means that the Norseman airstrip upgrade must be completed and recouped prior to submitting an application. Neither of these Departments will call for funding applications for a few months yet but we, in cooperation with Puzzle Consulting, will begin preparing funding applications shortly.

Other funding bodies will also be approached such as the Goldfields Esperance Development Commission and other bodies that will be identified at a later time.

In the meantime, management will immediately begin seeking letters of support from relevant and influential organisations for this project. An approach to the media might also add some weight to the project as a way of projecting the critical safety benefits of having an all weather airstrip.

One area of concern was an adequate supply of fresh water for construction purposes and as an additive for the bitumen emulsion. Early investigations reveal that this matter may now be able to be partially overcome by slightly changing the construction methodology without adding to the costs of the project.

By far the biggest hindrance to the Shire submitting funding applications is the “ownership” of the land on which the airstrip is situated. Currently, the airstrip sits on Unallocated Crown Land, controlled by the State. A request has been put forward to the Department of Planning, Lands and Heritage to have a Management Order of the Reserve on which the airstrip sits vested in the Shire of Dundas. This matter is progressing, albeit slowly though the Government process and a verbal report will be presented to the Meeting.

Summary

Background



This project has been part of the Shire's forward planning for several years with the building having been purchased during 2014/15.

The Council at its ordinary meeting held on the 20th June 2017 approved appointment of Cartman Designs for the preparation of concept drawings and full documentation including Architectural drawings and specifications.

The Council at its ordinary meeting held on the 26<sup>th</sup> March 2018 resolved the followings:

**"That the Council of the Shire of Dundas,**

- 1. Note the progress to date on the Woodland Centre project;**
- 2. Approve the concept design given in papers relating subjective a maximum total construction cost of \$2.2 million; and**
- 3. Delegate authority to the CEO, in consultation with Council, to appoint a suitably qualified project manager for the project in line with the scope of work given in papers relating."**

#### Comment

Considering the complexity and other challenges associated with the project, the service of a suitably qualified consultant is paramount important for the success of the project.

In line with the scope of work presented to the Council in its March ordinary council meeting, proposals were requested from four potential consultants. Successively, three consultants confirmed their willingness to manage this project in line with the defined scope, submitting their quotations.

Officers have carried out reference checks and all of them have been highly recommended by their respective referees.

Proposals submitted by each consultants are attached with this agenda. A summary of key information is provided below.

Both GFG Consulting (GFC) and Kal Engineering (Kal Eng) have experiences in providing project management services to other LG entities. Further, some of the consultants of GFC have previous experiences in working in LG sector assessing and managing similar projects.

GFC has a large network of in-house consultants representing different fields which will add value to a project of this nature. The in-house capability also assists the GFC in meeting the shire's stated milestones, noting the importance of the 18<sup>th</sup> May 2018 milestone. They are a WALGA preferred supplier and their team have experience working on projects regional and remote based using technology to limit the need for unnecessary travel and limiting costs where suitable. Travel time to and from Perth is charged at half the associates hourly rate.

The proximity and local networks of a consultant is an important factor in considering limited in-house resources available (internal expertise of the Shire) in managing a project of this nature. Kal Eng is based in Kalgoorlie and as a result, they will be able to provide a more service in terms of on-site support.

Kal Eng has managed similar projects in Esperance and Goldfields region and has a good network of supporting consultants (hydraulics, drafting, Building Surveyor etc.). This may help the Shire in achieving more cost savings compared to the cost involved in working with consultants based in Perth.

Local knowledge of regional consultants have been extremely helpful in managing the upgrade project of Norseman airport and it will stand relevant for this project as well.

Wallace Engineering, Darren has been instrumental in bringing the Norseman airport upgrade project well on track. His project management capabilities have helped the Shire immensely in achieving cost savings in the project. Though Darren's area of expertise is in the civil engineering field, he has managed similar projects (structural engineering projects) at the Shire of Coolgardie.

### **Whole Life Costing (WLC)**

Consideration of all relevant costs and revenues associated with the acquisition and ownership of an asset is key to ensure financial sustainability of a project of this nature. Essentially whole life costing involves comparing options and their associated cost and income streams over a period of time. There are many components in WLC namely construction cost, capital renewal cost, operational cost, maintenance cost and associated income flows. Operational cost, maintenance cost and income streams will largely depend on the way an asset is being used once it is developed/acquired.

In relation to the Woodlands Centre project, operational cost, maintenance cost and income streams will depend on the way the Council is planning to use the building when it is developed. In other words, the operating model that Council is contemplating to implement. The Council will have to confirm details of the proposed model and expected income and expenses streams for an outside consultant to provide a more comprehensive analysis of WLC of this project.
