## Statutory Environment

In accordance with the Local Government Act 1995 Part 6 Finance Management, Division 5 Financing Local Government Activities -

Subdivision 2 – Fees and Charges

Section 6.16 Imposition of Fees

(1) A local government may impose\* and recover a fee or charge for any goods or service it provides or proposes to provide, other than a service for which a service charge is imposed.

In accordance with the Local Government Act 1995 Part 6 Finance Management, Division 5 Financing Local Government Activities -

Subdivision 2 - Fees and Charges

Section 6.19. Local government to give notice of fees and charges.

If a local government wishes to impose any fees or charges under this Subdivision after the annual budget has been adopted it must, before introducing the fees or charges, give local public notice of — (a) its intention to do so; and (b) the date from which it is proposed the fees or charges will be imposed.

## Comment

The Fees and Charges contained in the schedule have been increased by 3% and have been rounded to allow for ease in transactive procedures and process. The Fees and Charges

increase reflects the Council's approval of the increase for the differential rates approved by Council Resolution during the Special Council Meeting on 14 May 2024. This decision was based on Council's strategic direction and goals to provide services and facilities that benefit the community, encourage local economic growth and industry, while ensuring good governance, and sustainability.

There are several fees and charges contained in the schedule that have differ from the 3% application. These are:

- Legislative Fees (highlighted blue in the schedule) have been updated or left the same in accordance with their relevant regulation.
- Aged Persons Units rent which is calculated in accordance with the human services aged pensioner payments have not been increased.

## Norseman Woodlands to Eucla Coast

- A greater increase to staff housing rent has been applied to better reflect the value of the housing. The increase does not preclude the CEO from providing different housing benefits in staff recruitment and contract negotiations.
- A greater increase to Shire housing rent has been applied to better reflect the value of the housing.
- The Shire owns and operates three retail business Norseman IGA, Norseman LPO, and the Norseman Visitor Centre which sell product and services to the public. The price of these products and services are calculated at the recommended retail price, this price is influenced by commercial agreements and supply.

Four new fees have been added to the schedule to reflect the user pay cost recovery and current services provided:

• Firewood - The Shire's activities with tree risk management, road works and private works provides an opportunity for use of harvested trees, and limbs. Instead of going to waste the Shire is selling firewood, and or milled slabs.

Some residents and rate payers will be eligible for concession rates.

- Trailer Hire x4 Box- Trailer hire for public use at half and full day rates.
- BBQ Trailer Hire
- New Plant added to the schedule is the Kubota Skid Steer, and Tip Truck (15tonne).
- The Norseman Community Resource Centre Fees have been updated to better reflect the service delivered, and to membership bundles have been reviewed to encourage engagement with services.
- The Hire of the Main Street Arcade was removed from the schedule.

This is to correct the date from the 1st of August 2025 to 2024

#### Officer Recommendation
